Mr Dore and Ms Gunn, today *The Australian* has published an antagonistic article denigrating legitimate concerns about the rushed Covid-19 vaccine rollout, i.e. Jack the Insider's diatribe [How to spot an anti-vaxxer: the most dangerous people on the planet](#), see copy attached.

While Jack the Insider may choose to have Covid-19 vaccination for his own medical reasons, it's concerning *The Australian* gives him a platform to demonise others who are rightly concerned about the rushed rollout of the fast-tracked, experimental Covid-19 vaccine products, without due ethical consideration and consultation with the public.

I left a response on Jack the Insider's article. Needless to say it has been censored, as is often the case with comments that seek to provide more content to the story. (See copy of my 'Pending' comment attached.)

See below my censored response to Jack the Insider, quoting from his article. My response contains information that is being withheld from other Australians by your deeply conflicted publication.

***COVID-19 vaccines have been subject to accelerated clinical testing. That doesn't mean the testing has been inadequate...***

Doesn't it?

You're very sure of yourself 'Jack the Insider', with your contemptuous attitude towards people who are rightly questioning the unprecedented campaign to vaccinate the entire global population with fast-tracked experimental Covid-19 vaccine products.

FYI, the Pfizer and AstraZeneca vaccine products have only been 'provisionally approved' by the TGA. Health Secretary Brendan Murphy misled the Australian public when he assured Leigh Sales on ABC 7.30 that the Covid-19 vaccine products have ***"gone through the normal, full range of regulatory approvals for our vaccines...we have been able to do the full, safe, regulatory approval..."***

Mr Dore and Ms Gunn, *The Australian* is abusing its position as a media platform to publish biased articles which support its corporate interests, i.e. its corporate partnership with the Murdoch Children's Research Institute which is involved in vaccine research, including Covid-19 vaccine research with the Doherty Institute of Infection and Immunity.

**It really is a serious matter that you continue to fail to disclose conflicts of interest**, particularly with the Murdoch media's history of influence on taxpayer-funded vaccination policy, i.e. its media campaign in 2013-2015 for the coercive No Jab, No Pay/No Play laws, which are now being considered for coercive Covid-19 vaccination, as discussed in my email to Scott Morrison mentioned above.

Kevin Rudd recently admitted he was frightened of Rupert Murdoch when he was Prime Minister, and that the 'Murdoch mob' was seeking 'compliant politicians'. **There needs to be an investigation into the Murdoch media/News Corp Australia's influence on Australia's politicians and taxpayer-funded vaccination policy.**

We desperately need an objective and independent 'fourth estate' to shine a light in the dark corners of government and manipulation of taxpayer-funded vaccination policy by corporate interests, such as News Corp Australia/Murdoch Children's Research Institute.

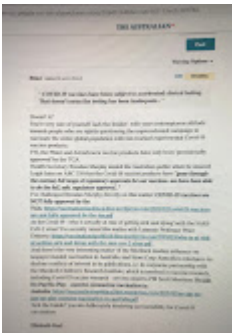
