Mark Butler, *The Australian* reports today: "**Opposition health spokesman Mark Butler says Scott Morrison must sanction and not just rebuke rogue MPs over anti-vaccine rhetoric.**"

Mark Butler, you are a disgrace. How dare you deliberately impede examination of the disastrous Covid-19 'leaky vaccines' rollout.

These defective jabs are an experimental medical intervention being undertaken without valid informed consent. **Stop with the puerile 'anti-vaccine' name-calling, and do your duty and take this matter seriously.**

Five-year-olds are now being given these injections, when it's known they're not at risk of Covid-19 - why is this happening?!?!?!?

Why aren't you hauling the Australian Technical Advisory Group on Immunisation (ATAGI) over the coals on this matter?

You use *The Australian* to call for genuine representatives of the people to be sanctioned and rebuked for calling the alarm on the Covid-19 'leaky vaccines' rollout, you are a danger to the Australian people.

The Australian/News Corp Australia is deeply conflicted in this matter, in that News Corp Australia is a **corporate partner** with the Murdoch Children's Research Institute, which is involved with vaccine research, **including Covid-19 vaccine research** with the Doherty Institute, a conflict of interest that isn't disclosed in News Corp Australia publications. It was **the Doherty Institute' modelling** which put Australia into lockdown and restrictions in March 2020, influenced by the infamous modelling of Neil Ferguson et al, i.e. Imperial College **Report 9**, which

recommended 'suppression' of the virus (aka lockdown), "until a vaccine becomes available". It wasn't disclosed in Ferguson et al's Report 9 that **Neil Ferguson is funded by the Bill & Melinda Gates Foundation**, an organisation which has influenced international vaccination policy for over 20 years, via the WHO, Gavi, CEPI etc.

It was also News Corp Australia publications such as the tabloid *The Daily Telegraph* that campaigned for **coercive vaccination laws with its 'No Jab, No Play' campaign** in 2013-2015, with the No Jab, No Pay bill being raised by then Social Services Minister Scott Morrison in 2015, during which year Morrison also had a **private lunch with Rupert Murdoch**. The No Jab, No Pay law was enacted in 2016, followed by No Jab, No Play laws in the states. **We now see the 'No Jab' concept enabled by Scott Morrison being used to impose mandatory Covid-19 injections**, e.g. No Jab, No Job; No Jab, No Restaurant; etc...and No Jab, No Life, as soon to be rolled out under Western Australia's dictator Mark McGowan, **based on "the latest health advice"**, i.e. discrimination against critical thinking people who refuse to submit to repeated shots of defective Covid-19 'leaky vaccines', and risk sabotaging their own natural immune response.

In March 2020 Scott Morrison closed Australia's international border, and held Australians captive for 'the vaccine', and is now determined that everyone will be jabbed over and over again with these defective injections, with **the 280 million doses** that have been 'secured' for the population of 26 million, costing billions of taxpayers' dollars. **Australians aren't free to leave Australia** without special exemption unless they submit to repeated shots of Covid-19 'leaky vaccines', an experiment which is increasingly looking like a disastrous failure and threat to people's natural immune response.
