Mark Butler, as you know, my colleague Emma McArthur and I have been pursuing matters re voluntary informed consent and the Covid jab mandates, **also including an investigation which has revealed the former Morrison Government lied to health practitioners about them having specific medical indemnity for administering Covid jabs**...it nows turns out only a 'no fault' vaccine claims scheme was put in place for people with vaccine injuries, **health practitioners don't actually have specific Covid jab medical indemnity after all...**

**The Australian Medical Professionals' Society (AMPS) has taken up this matter, warning medical practitioners and professionals that administering of Covid-19 vaccination is likely not an indemnified action.**

**What is the Department of Health and Aged Care doing to address the matter - are health practitioners being warned they may have a medical indemnity risk in administering Covid jabs?**

This isn't just about medical indemnity for health practitioners - **the primary concern should be for the millions of people who have been mandated to submit to the jabs, and denied the freedom to properly consider the risks and benefits of the Covid jabs in their own particular health circumstances, including for children.**

The main upshot of the matter is that we have recent confirmation from the Department of Health and Aged Care that: **"Informed consent should be obtained for every COVID-19 vaccination, as per usual consent procedures for other vaccinations."**

But this is not happening, **certainly not under jab mandates.**

**Voluntary informed consent has been trashed in Australia**, and, among others including politicians and bureaucrats, **this can very much be laid at the feet of the medical profession and AHPRA, which should have risen up against administering vaccinations imposed under a mandate.**

**Mark Butler, please advise what action the Department of Health and Aged Care is undertaking to address voluntary informed consent, Covid jab mandates and medical indemnity.**

This is an important matter of public interest and I look forward to your early response.
